I wish to participate in a BC Randonneurs Cycling Club (the "Club") cycling event. As a condition of being allowed to do so, I hereby confirm and agree that I recognize that this event requires physical exertion while cycling a designated route in traffic for long distances both day and night which may be strenuous and may cause physical injury, and I am fully aware of the risks and hazards involved, including **NEGLIGENCE ON THE PART OF THE CLUB OR ITS DIRECTORS, OFFICERS, ORGANIZERS, MEMBERS, AGENTS, AND ANY PERSON ASSISTING DIRECTLY OR INDIRECTLY WITH THE ORGANIZATION AND CONDUCT OF AN EVENT (THE "VOLUNTEERS"), INCLUDING THE FAILURE ON THE PART OF THE CLUB OR ANY OF ITS DIRECTORS, OFFICERS, ORGANIZERS, MEMBERS, AGENTS, AND VOLUNTEERS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS, AND HAZARDS OF THE EVENT,** and I agree to take full responsibility for the foregoing and for any risks, injuries or damages which I may incur as a result of my participation in the cycling event, including **THE POSSIBILITY OF PERSONAL INJURY OR DEATH.**

In consideration of the Club allowing me to participate in the cycling event, I hereby agree:

- (a) TO KNOWINGLY AND VOLUNTARILY WAIVE ANY AND ALL CLAIMS I may now or in the future have against the Club or its directors, officers, organizers, members, agents, and volunteers (collectively the "Releasees") for any injury or damage including death that I sustain as a result of my participation in the cycling event;
- (b) TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense, or injury including death that I or my next of kin may suffer as a result of my participation in the event, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE ON THE PART OF THE RELEASEES, AND ALSO INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO WARN OR TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS, AND HAZARDS OF THE ACTIVITIES REFERRED TO ABOVE; and
- (c) TO INDEMNIFY AND SAVE HARMLESS THE RELEASEES from any and all liability for any damage to property of or personal injury to any third party including death resulting from my participation in the event.

**I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, EXECUTORS, ADMINISTRATORS, SUCCESSORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES.**

**I HAVE READ THE ABOVE RELEASE AND WAIVER OF LIABILITY, FULLY UNDERSTAND ITS CONTENTS, AND SIGN IT WITH FULL KNOWLEDGE OF ITS SIGNIFICANCE. I VOLUNTARILY AGREE TO BE BOUND BY THE TERMS AND CONDITIONS STATED ABOVE.**
