## President's Report – Andy Reimer

- Canada Day Populaire Andy will be organizing. Walnut Grove Community Park is the likely start location (Yorkston Community Park is the alternate). Waivers and permit acquisition is underway. - Rocky Mountain 2020 Andy has established a new one-way route, Canmore to Jericho Beach. Looking to include a bus service to start and hostel accommodation.

#### **Treasurer's Report** – Andy for Darren MacLachlan

Not much to report. Darren is back next week if anyone is looking for cheques. Will need to account for Rocky Event expected shortfall in this year's planning.

# **Regional Route Coordinator's Reports**

Southern Interior – Bob Goodison The SI200 had 16 riders (more than usual) and all were local, and all finished!

Vancouver Island – Mike Croy

Successful VI300 event, and the VI400 is ready to go (both with new organizers). Mike has modified the VI600 route slightly from original intention.

Lower Mainland – All for Chris Cullum

LM 300 Hemlock Valley control at the end of the pavement (avoiding the gravel climb) worked out well. Fleche event well received. Still looking for an organizer for the LM Summer 600 brevet.

Discussion of the June11 'Vancouver City Limits 200'.

## Fleche Pacifique Report – Colin Fingler

15 Teams - 7 Fleche and 8 Trace. 7 teams were US based.
67 riders in all; 82 attendees at the brunch
Event expenses: \$4700 against revenue of \$4100 (typical year)
Colin to book 2017 event (and two bedroom cabin)
Also for 2017, consider fee increase, new organizers & expansion of brunch to non-event riders as a social event.
Need to clarify rules for LFL award & extra distance criteria.

# Rocky Mountain 1200 Report – Jeff Mudrakoff

- 1. Rider count seems to have stalled around 75 riders.
- 2. Event Budget is projecting a loss of \$10-\$15k at this level of riders.
- 3. Organizing committee is looking at ways to reduce losses, including reducing the volunteer count.
- 4. Some discussion of why the low count. Perhaps pre-registration is not the way to go versus direct payment. Lateness in committing to the event may also have been a factor.
- 5. Pre-ride is July 11-14. Ten riders.

# Other Business

## Award Event Eligibility – Jeff email background

[from April mtg] General discussion on the event eligibility criteria for BCR awards, lifetime mileage, BC-12 with respect to various 'grey area' events including FFCT permanents, Audax brevets, Super 600. Reviewed Jeff's summary email – lots of discussion including using the existence of a homologation # to identity out of BC rides for 'credit' – not sure we came to a clear & final consensus.

Action: - Jeff to summarize recommendations and forward to exec for approval

## VicPop Report - Steve Mahovlic email

Thoughtful and thorough final report (25 April) sent to all executive posing some 'existential' questions as to the BCR objectives with the Vic Pop. Included many tips and lessons learned for the benefit of future organizers of the event.

Andy suggested that purpose of populaires (i.e. organized bike ride) is (in order):

- a. raise \$ for club activities, particularly the longer events
- b. act as a 'soft' recruitment/intro to randonneuring to new riders
- c. provide a community event (particularly Victoria)

Action: all exec to review and comment to Andy on Steve's final report/checklists. Andy to draft a response to Steve.

#### Non-Member Permanents Eric Fergusson email

[from April mtg] Eric Fergusson submitted an email looking for input from Bob Koen (permanents coordinator) & the exec on a request from a Dutch randonneur to become a BC randonneur to set up out-of-BC permanents to utilize our reporting 'infrastructure'. Lots of discussion particularly on liability/insurance questions for out-of-province rides - no resolution.

Action: Andy to solicit Permanent Coordinator Bob Koen's thoughts on this issue & also follow-up with Vanessa (insurance contact)

Given the insurance/liability evolution of many business items, Etienne suggested that an insurance 'FAQ', would serve us well. Colin to draft a starting list of questions.

**Vancouver City Limits 200** – Eric Fergusson email background Eric (in discussion with Chris Cullum) proposed to organize the 11 June LM200, using a new 'novelty' route which lies entirely within the Vancouver City Limits. He requested executive approval to setup a temporary web page and print/distribute promotion bookmarks. Executive approved request.

### Insurance FAQ (Draft):

- 1. What is the insurance/liability distinction between public events (populaires) and club events (brevets) and permanents?
- 2. What is the significance of needing a memberships (club event) or not (public event), even if an event waiver is signed.
- 3. What is the insurance criteria/significance for the type of events we organize (i.e. eco-tourism, US routes, >50 participant cutoff, distance)
- 4. Jeff recalled previous discussion on the need for both parents' signatures on a Minor's Event Waiver form & will research whether the club may have already had a lawyer's opinion on this. (2013 BC Court Case Wong vs. Lok's Martial Arts Centre)
- 5. Given the recent last-minute 'blow-up' on Capri's forms requirements for the VicPop, what should be on the organizer's checklist to prevent a similar future event for all rides open to the public (non-members)?
- 6. What is the liability to event (non-member) volunteers and to organizers for volunteer actions (or lack of)?
